LICENSURE OF CONSUMABLE HEMP PRODUCTS
ORDINANCE NO. 2026-04-14-1

AN ORDINANCE AUTHORIZING THE SALE OF CONSUMABLE HEMP PRODUCTS
WITHIN THE CORPORATE LIMITS OF THE TOWN OF HAYDEN, ALABAMA, SUBJECT
TO STATE REGULATION

WHEREAS, the Town of Hayden, Alabama, desires to permit lawful commerce within its corporate limits; and

WHEREAS, the State of Alabama, through the Alabama Alcoholic Beverage Control Board (ABC Board), regulates the manufacture, distribution, and sale of consumable hemp products under Chapter 20-X-33, Licensure of Consumable Hemp Products; and

WHEREAS, the Town of Hayden finds it to be in the best interest of the public health, safety, and welfare to allow or deny the sale of consumable hemp products in accordance with applicable state laws and regulations for:

Pharmacy: YEA 5 NO 0 ABSENT 1

Retail: YEA 0 NO 5 ABSENT 1

Convenience Store: YEA 0 NO 5 ABSENT 1

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Hayden, Alabama, as follows:

SECTION 1. PURPOSE

The purpose of this ordinance is to permit the sale of consumable hemp products within the corporate limits of the Town of Hayden, for the agreed upon YEAS entered, provided that all applicable state laws and regulatory requirements are satisfied.

SECTION 2. DEFINITIONS

For purposes of this ordinance, “consumable hemp products” shall have the same meaning as defined by the Alabama Alcoholic Beverage Control Board under Chapter 20-X-33 and applicable Alabama law.

SECTION 3. AUTHORIZATION OF SALES

The sale of consumable hemp products is hereby permitted within the corporate limits of the Town of Hayden, Alabama for the agreed upon YEAS herein.

SECTION 4. COMPLIANCE WITH STATE LAW

Any individual, business, or entity seeking to sell consumable hemp products within the Town of Hayden must:

1. Obtain and maintain all required licenses and permits issued by the Alabama Alcoholic Beverage Control Board under Chapter 20-X-33, Licensure of Consumable Hemp Products;
2. Comply fully with all rules, regulations, and requirements established by the ABC Board and applicable Alabama law; and
3. Maintain such licenses in good standing at all times while engaging in the sale of consumable hemp products.
4. Must display license in a visible area inside the business.

SECTION 5. LOCAL BUSINESS LICENSE REQUIREMENT

Upon approval of an application by the Alabama Alcoholic Beverage Control Board for the sale of consumable hemp products, the applicant shall be required to purchase a separate business license from the Town of Hayden specific to the sale of consumable hemp products.

This license shall be in addition to any other business license required by the Town of Hayden. The fee for such license shall be determined by the governing body of the Town of Hayden and may be amended from time to time.

SECTION 6. LOCAL AUTHORITY

The Town of Hayden reserves the right to enforce all applicable municipal ordinances, including but not limited to business licensing and public safety regulations, as they relate to establishments selling consumable hemp products.

SECTION 7. VIOLATIONS

Any person or entity found to be in violation of this ordinance, including failure to comply with ABC Board requirements, may be subject to penalties as provided by applicable law and municipal ordinance.


SECTION 8. SEVERABILITY

SECTION 9. EFFECTIVE DATE

This ordinance shall become effective immediately upon its adoption and publication as required by law.


